It's deja vous all over again. We are participating for the third year in a row in the INTERNATIONAL LIGHTHOUSE/LIGHTSHIP WEEKEND. The event is from 0001 UTC on Saturday 18 August until 2359 UTC on Sunday 19 August 2001. EARS. will be setting up transmitters and receivers at the Boca Grand Lighthouse on the southern tip of Gasparilla Island and operating station K8ONV during the daylight hours from approximately 8 AM. until sunset.

Over 200 amateur radio stations will transmit from lighthouses and lightships in over 40 countries. The event is NOT a contest, each station decides how they will operate their station regards modes and bands. Participants are not committed to being on the air during the entire period - only as much as they can. There are no restrictions on aerials or power. Operators will have a chance to enjoy themselves and have fun while making contact with as many amateur radio stations at other lighthouses and lightships as possible.

# **Old Business**

The motion last month to authorize a total of \$500 towards Hamfest

2002 was discussed thoroughly. Ken Anderson called the question and the motion passed unanimously.

#### **New Business**

There was discussion of August's Lighthouse weekend activity at the Boca Grande Lighthouse. Out activity will be publicized both in CO and OST .

Program: The speakers were Jerry Mechenberg and Judy Abbott of the U.S. Coast Guard Auxiliary discussing the 'Sea Partners' program. They had a multimedia presentation detailing the problems with sea pollution. Much of it is visible, styrofoam cups, garbage bags, balloons. It is a real problem for sea animals that either get caught in them or mistakenly ingest them. Soap is very dangerous due to the carcinogens it contains. People caught littering the ocean, either from boat or from shore, are subject to big fines. Garbage dumping of plastic in any form is illegal. Finally we watched a video about a pygmy sperm whale, nicknamed 'Inky', who washed up on our eastern shores in an emaciated condition. Medical examination finally showed that Inky's stomach was filled with various bits of plastic residue, including a large piece of a garbage bag. All this was making it impossible for him to absorb nutrients from what food he was eating. They were able to remove all this debris and the little whale then made a speedy recovery.

The meeting adjourned at 9:10 p.m. There were 25 members and six guests present.

# **CHARLOTTE COUNTY SKYWARN PROGRAM (June 2001)**

- **1. Skywarn may be activated by** a National Weather Service (NWS) Alert by an announcement on the Weather Radio, K4WCF repeater, or by NWS links to local Charlotte County Repeaters.
- 2. The Alert Status may be:
  - A. Condition BLUE--Standby Net.
    - 1. WX4TBW, the NWS Amateur Radio Station in Ruskin, will activate a Standby Skywarn Net on the 442.95+MHz, PL 100, K4WCF repeater.
    - 2. County Skywarn Net Control Operators will monitor and notify WX4TBW of their status.
    - 3. WX4TBW will relay NWS weather (wx) bulletins, and advisories on the K4WCF repeater.
    - 4. WX4TBW will identify its call every 10 minutes, and send a short Tropical Alert Message every 15 minutes.
  - B. Condition YELLOW--Watch Net. (WX4TBW will upgrade to Condition Yellow).
    - 1. Charlotte County Skywarn Net Control Operator will activate the local Skywarn Repeater on 147.255+ MHz (W4DUX) or alternate 146.925- MHz (WA9NLA) repeater.
      - a. Charlotte Skywarn Net Control will:
        - 1. ID the station as the primary local Skywarn Net, either formal or Informal.
        - 2. State the reason for Skywarn Net Activation, and Condition Yellow Status.
        - 3. Ask for an Alternate Net Control Station operator volunteer.
        - 4. Monitor WX4TBW and check in as indicated above in para. 2.A.2.
    - 2. Local County Spotters will check in with Call Sign, Skywarn ID, Location, local WX info.
    - 3. Local Net Control will check in to WX4TBW and advise status. Non-hams use -800 phone.
  - C. Condition RED--Warning Net. (Severe Weather Imminent or Spotted). (WX4TBW is Condition Red).
    - 1. Charlotte County Skywarn Net Control activates the local Skywarn Net as Condition RED and notifies all spotter stations to report severe weather and/or related damage to local Net Control only, using their call sign and spotter ID. Spotters should report the following weather criteria:
      - a. Winds of 58 mph, or greater.
      - b. Dime size or greater Hail.
      - c. Local Flooding details.
      - d. Estimated rainfall of 2" or more per one hour period, or 4" per day.
      - e. Funnel clouds, waterspouts and tornadoes.
    - 2. Each Severe Weather Spotter Report should contain a Call Sign, ID #, County, location, weather criteria and when available details of weather travel, wind direction, etc. Call sign exchange completes each report. Spotters continue to monitor the Skywarn Net
    - 3. Damage Reports--Location, description, injuries and death, estimate of time occurred.
    - 4. Only Local Skywarn Net Control will coordinate and pass spotter reports to WX4TBW. This will limit the field reporting and reduce QRM to WX4TBW, the K4WCF Repeater, and -800#.
- **3. ARES/RACES-** In the event of a Tropical Storm, Hurricane, or disaster, requiring activation of ARES/RACES, local county EOC communication plans will become effective. The Skywarn Net will be notified of ARES/RACES activation by the EOC Coordinator. The Local Skywarn Net may QSY to alternate frequencies depending on available resources.
- 4. COUNTY SKYWARN NET ACTIVATION may occur without NWS Alert as weather conditions warrant.

Local Skywarn net control will coordinate spotter reports and communicate with NWS via -800 phone.

#### 5. Required Radio Gear:

- A. County Skywarn Net Control should have available the capability of:
  - 1. Transmitting a reasonable quieting signal into the local Skywarn Repeater. (147.255+MHz) or alternate (146.925-MHz).
  - 2. Communicating with the Manatee County K4WCF repeater on 70CM UHF (442.95+MHZ, PL100), and VHF (145.43-MHz, PL 100), which the NWS and WX4TBW will be utilizing for Skywarn and ARES/RACES operations respectively.
  - 3. HF Communication backup with NWS and WX4TBW on either 3.911 or 7.281MHz.
  - 4. Operating with emergency power.
  - 5. APRS communication on 144.390MHz and/or the Internet.
  - 6. Immediate access to a telephone. (-800 hotline).
